BE IT RESOLVED, That the Christiania Lutheran Church Council hereby approves the Christiania Lutheran Church Burial Policy, as presented on September 6, 2016, and hereby directs future burial receipts to be split 50/50 with the Foundation and Cemetery Maintenance/Expense account.

#### Motion not passed for above topic. Concerns/recommendations:

- Adding a third rate for General Public, higher than that of "Non-active" members
- Terminology to align with Constitution, regarding description of member classifications.
- · Look at what actual fees are for other cemeteries, to know market pricing & how it compares to ours
- Bruce Mohn to work with Property Committee on details mentioned above

BE IT RESOLVED, That the Christiania Lutheran Church Council hereby approves the establishment of a Columbarium, Peace Garden, Memory Wall Fund Raiser. Notice of this fund raiser will be placed in the October Newsletter.

#### Motion not passed for above topic. Concerns/recommendations:

- Executive Council would need more information, like on pricing, etc...to go on before a decision can be made
